Eligible Participant	<p>Entry is only open to Australian residents who are 18 years and over.</p> <p>The directors, officers and employees of the Promoter and its related bodies corporate and their immediate families and any of the Promoter's contractors associated with this Promotion and their immediate families are not eligible to participate in this Promotion.</p> <p>Excluded Persons are not eligible to participate in this Promotion. "Excluded Persons" means any person identified as a minor, a self-excluded patron or an involuntarily excluded patron. If a person is identified as an Excluded Person, the Promoter reserves the right to refuse to allow the person to take part in the Promotion, or receive, any or all aspects of the Prize, and the Promoter will notify any relevant regulator accordingly where required by law to do so.</p>

General Terms and Conditions

Any person entering this promotion ("you") acknowledge and agrees that you have read these Conditions of Entry and that by entering the Promotion you are deemed to have accepted these Conditions of Entry.

1. Taxes

2. Exclusion of Liability

- a. 4. General

 - ii. any injuries, losses (including, without limitation, loss of profits), or damages of any kind caused by the Prize or resulting from acceptance, possession, use, or misuse of the Prize, or from participation in the Promotion or downloading material from hbt.net.au; or
 - iii. any printing or typographical errors in any materials associated with the Promotion.
- b. The Promoter reserves the right to:
